**Report on the Audit of UNDP Guatemala**  
**Programa de Desarrollo Metropolitano de la Municipalidad de Guatemala**  
**(Project No. 36408, Output Nos. 39570, 46679 and 46682)**  
**Executive Summary**

The UNDP Office of Audit and Investigations (OAI), through PKF Littlejohn LLP (the audit firm), from 23 May to 8 June 2022, conducted an audit of *Programa de Desarrollo Metropolitano de la Municipalidad de Guatemala* (Project No. 36408, Output Nos. 39570, 46679 and 46682) (the Project), which is nationally implemented with support services provided by the UNDP Country Office in Guatemala. The last audit of the Project was conducted by OAI, through PKF Littlejohn LLP in 2021 and covered project expenses from 1 January to 31 December 2020.

The audit firm conducted a financial audit in accordance with the International Standards of Auditing (ISA), the 700 series, to express an opinion on whether the financial statements present fairly, in all material aspects, the Project's operations. The audit covered the Project's Combined Delivery Report, which includes expenses for the period from 1 January to 31 December 2021 and the accompanying Funds Utilization statement<sup>1</sup> as of 31 December 2021. The audit did not cover the Statement of Assets as no assets were held by the Project. In addition, the audit did not cover the Statement of Cash Position as no separate bank account was established and maintained for the Project.

The audit was conducted under the general supervision of OAI in conformance with the *International Standards for the Professional Practice of Internal Auditing*.

#### **Audit results**

Based on the audit report submitted by the audit firm, the results are summarized in the table below:

\*Expenses recorded in the Combined Delivery Report were \$14,575,908. Excluded from the audit scope were transactions amounting to \$203,107 that related to expenses incurred by the responsible party.
